We also stand with communities before, during and after an emergency. Our emergency response network means we can respond immediately because we work with local partners and churches already in country.


#### **Low Administration Fees**

The shelter where Martina sought refuge is a partner in Caritas Australia's Protection Program. This holistic community-wide program offers women like Martina economic empowerment and a life of safety in a supportive environment.

"After I left the shelter, I felt confident for my future. They really helped me to learn how to be strong; how to change my life to support myself and to have some money to support my children," Martina says.



## Leaving a Legacy of Love

Preparing your Will helps to look after your loved ones and gives peace of mind. We understand that your family and friends come first and that leaving a gift in your Will is a personal decision.

Whether you're writing a new Will or amending an existing one, including Caritas Australia is simple.

There are three different types of gifts you may consider:

- A Residuary Gift: the remainder of your estate after all expenses, debts and taxes have been paid, and after any specific gifts.
- A Percentage Gift: a percentage of your residuary estate. This gift is used if you wish to divide your estate among a number of people or organisations.
- A Specific Gift: a sum of money, property or shares. You can ask your solicitor to draft a cash gift to account for inflation.

Your generous gift will make a real difference. Whatever you decide, we recommend that you work with a solicitor to write your new Will, or amend an existing Will.

Your solicitor should ensure that your Will includes the correct legal name of our organisation and ensure that the gift can still be made if our organisation changes its name during your lifetime.

## The wording for your Will

It is easy to include Caritas Australia in your Will. You can use the suggested wording provided below.

#### I aive...

(Please insert the appropriate statement from the following options:)

A. The sum of \$ [insert value or description of your gift]

B. The residue of my estate

C. [insert number] % of the residue of my estate to Caritas Australia Limited (ABN 90 970 605 069) for its general purposes absolutely. The receipt of the authorised officer of the organisation shall be sufficient discharge to my executor. If the organisation cannot receive the gift, the gift shall be made to the charitable organisation in Australia that my executor considers most nearly fulfills the objects I intend to benefit.
